#### **PCU Industry Network**

We partner with local and international businesses who share our approach to business and education. Leading figures from industry are regularly invited into the classroom as guest speakers, and to run workshops using real-life case studies that give students insight into the world of professional work. Lecturers are engaged in ongoing research to find answers and solutions, many under the framework of the United Nations Sustainable Development goals (SDG). Their work is often funded by educational and governmental grants and several faculty members are on editorial boards of international Journals and are regularly indexed in Scopus and Web of Science (WoS)

Our students benefit from a faculty with a reputation for writing and research as their work influences and inspires students to think beyond what is already known. Students can also participate and contribute to research, conference presentations, teaching and programme development, further enhancing their level of knowledge and skills.

Some of the most recent achievements in research, practice and initiatives have been:





- Visegrad Project, Building International Bridges. The School of Business, in collaboration with the Centre for International Relations Foundation in Poland, the Ukrainian Center of the Future in Ukraine, and the Ukrainian House Žilina in Slovakia, received a Visegrad grant in 2023. As a result the School of Business will be actively involved in developing training courses and lectures focused on Business Strategies for NGOs in Ukraine and Visegrad countires.
- Joint Research Seminar series with Teesside University International Business School a platform for knowledge exchange and sharing of research.
- Publications on intellectual capital, corporate transparency, sustainable finance, corporate governance and banking published and indexed in Scopus and Web of Science (WoS) databases. Areas of research include Sustainable Development Goals, Intellectual Capital, Collaborative Trust relating to contract lifecycle management (CLM) processes in supply chains, Human Resources Management, Business Models in Economics of Culture, Cryptocurrencies, Corporate Governance in the Financial sector, Corporate Social Responsibilities and Business Ethics.
- Regular participation in international conferences with research work presented.
- CSR project with Unibail-Rodamco-Westfield (URW) the development and delivery of a business skills programme for long-term unemployed.

#### Centre for Research and Interdisciplinary Studies

The School of Business research and activities outside of the classroom fall under the umbrella of the University's Centre for Research and Interdisciplinary Studies (CRIS). Content is delivered in an engaging, interactive way, using project-based teaching methods. Continuous tutorial support, including assistance with academic writing, fully prepares students for future studies.

Students have the choice to study in person in Prague, or earn their diploma through distance learning. Delivered online through our Digital Campus, students follow live lessons on Zoom and receive all recordings and have access to digital resources.

The Foundation Diploma programme is continuously updated and enhanced, ensuring that it remains progressive and relevant. Students who successfully complete the Foundation programme are awarded the BTEC International Level 3 Diploma in Business (the equivalent of two British A-levels).

On completion, the diploma offers a clear pathway into the BA (Hons) in International Management, or BA (Hons) in International Finance & Business Accounting. If students prefer to explore a different subject area, skills gained in this year should also allow transfer to Bachelor's level programmes in other PCU Schools.



The International Management programme is designed to equip students with a progressive knowledge base and a broad range of skills, along with an understanding of the forces and complexities which drive modern international business.

The highly practical nature of this programme, delivered in consultation with local industry partners, allows students to gain experience and skills by participating in case studies, workshops and group work on actual client briefs, replicating real-life work scenarios.

Subjects such as negotiation, teamwork, leadership and management develop both confidence and a sense of value. In this way, the programme not only advances career prospects, but also builds awareness of a student's contribution to wider society.

Students have the choice to study either full-time (two semesters per year for three years), or through distance learning (eight semesters over three years), a programme specifically tailored for those already working professionally. Additionally, exam exemptions for the Chartered Institute of Management Accountants (CIMA/CGMA) are awarded upon graduation, and students can continue studying towards this prestigious certification.

Graduates typically go on to work for global businesses ranging from Fortune 500 companies to Non-Governmental Organizations. Others take the entrepreneurial route and set up their own businesses.

A specific benefit of this programme is the option to register with the Association of Chartered Certified Accountants (ACCA) or the Chartered Institute of Management Accountants/ Chartered Global Management Accountants (CIMA/CGMA) and qualify for generous exam exemptions for each association's professional qualifications. This offer can be taken up after graduation, or, in the case of ACCA Fast Track, even during studies. Individual support is also available from ACCA and CIMA/CGMA ambassadors connected to PCU.

This programme is ideal for those who enjoy the challenge of working in rapidly-changing organisations and have an intellectual curiosity and ability for complex analysis.

New business skills and experience are gained by undertaking real-life projects and case studies; and students are encouraged to develop advanced interpersonal skills to meet the high expectations of global working environments. The programme presents continuous opportunities to network with peers, academic staff and industry professionals, who advise and participate in class sessions. The core of the programme is a dissertation project, focused on an industry and topic of particular interest and relevance.



Additionally, Master's gateway exams are available (in lieu of the majority of lower-tier exams) which offer a fast-track to the prestigious professional qualification, offered by the Chartered Institute of Management Accountants/Chartered Global Management Accountants (CIMA/CGMA).

Designed for working professionals and recent graduates who aspire to advanced qualifications, the programme is offered in both Intensive (12 to 18 months) and Standard (24 to 30 months) formats with evening and weekend classes providing the flexibility needed to successfully balance work and study. Alternatively, students can chose to study through distance learning.

### **ACCA Professional Qualification**

The Association of Chartered Certified Accountants (ACCA) qualification provides practical skills that gives students a clear advantage in the rapidly changing field of finance and accounting. ACCA members are viewed as world-class experts in accounting and their knowledge is valued. PCU offers teaching and examination preparation for all ACCA applied knowledge and strategic professional stages.

Flexible teaching is arranged in consultation with the student and taught by fully-qualified lecturers. Content is delivered either in-person over weekends, during the working week or online. PCU also offers intensive revision courses which usually take place the week before exams.



I wanted to advance in my accounting career and ACCA felt like the natural path to follow. I studied accounting in my home country of Finland, but now I work in international accounting in Prague. I had an online coach at PCU which was definitely what I needed to move forward. The coach puts a little pressure on me and kept me motivated with my studies. ACCA can be quite tricky so it's good to have someone who can help and support when needed. I have also had very valuable hints on study and exam techniques, and some good tips for the exams.

### CIMA/CGMA Professional Qualification

The Chartered Institute of Management Accountants/ Chartered Global Management Accountants (CIMA/CGMA) qualification offers a blend of management accounting, financial accounting and business-focussed subjects that produce confident Management Accountants who can lead organisations.

PCU is CIMA's registered learning provider for the Czech Republic offering the CGMA Finance Leadership Programmes (FLP) three levels; Operational, Management and Strategic, and three pillars; Enterprise, Performance and Financial, FLP is a self-guided online programme that uses real-world case simulations to develop the entrepreneurial skill set and mindset needed. Lecturers are qualified and experienced in teaching the CIMA syllabus and exam preparatiohn. Teaching and revision courses are arranged in consultation with the student and delivered either in-person or online. Intensive revision courses are also available.



CIMA is a proven qualification attracting people who wish to be highly skilled practitioners in Management Accounting. Finance is the main driver that makes business function, so CIMA studies are very relevant to the changing business environment. I learnt new technologies such as Blockchain and Machine Learning, along with the skills required for joining the Association of International Certified Professional Accountants.

Applicants for **full-time or distance learning programmes** at Prague City University are eligible to apply for a scholarship covering up to 50% of tuition fees. Scholarships are awarded for either a single academic year or the duration of the programme.

The **Academic Excellence Scholarship** is for outstanding academic achievement and/or engagement in an academic context and the **Academic Excellence Progression Scholarship** is awarded to all Bachelor's degree graduates of any programme at PCU who decide to continue onto a Master's degree within the first year of finishing their Bachelor's degree.

The **Social Engagement Scholarship** is awarded for voluntary or school activities, or more generally for positive community engagement in society. At Master's level we also take into consideration applicants' work experience and contributions in the workplace.

The **Professional Excellence and Social Entrepreneurship Award for Distance Learning students** looks primarily for exceptional achievement in a professional and social context, as well as leadership and entrepreneurial skills. Evidence from the fields of business, IT or humanitarian engagement will be recognised.

### Support for local students

We also have a special fund to support students coming from Czech-language and Slovak-language secondary schools and universities.

### Industry Network discount

If you work for a company which is part of our Industry Network, you qualify for an automatic 10% discount, regardless of whether you or your company are paying the tuition.

### Bursary for Professional students

If you are employed by a company which agrees to contribute towards your distance programme studies, PCU will match a contribution from your employer, up to 20 % of the total tuition fee.


